* Fees must be based upon actual services rendered on hourly basis in an amount not- to- exceed the stated maximum amount. Hourly rates are \$60.00 per hour for in court services, \$50.00 per hour for out of court services.

** SVP means Sexually Violent Predator Spec. which, pursuant to R.C.2941.148 and Cuyahoga County Common Pleas Local Rule 33, Part II(B), increases the potential penalty for an offense to a life sentence and, therefore, increases the maximum fee by \$1,000.00 above the base maximum.

***Case Fee Applicable to pilot project cases only, 'Pilot project' cases are cases subject to early disposition reforms, as approved by the Cuyahoga County Criminal Justice Governing Board.

****Case Fee Applicable to Companion cases only. For multiple cases, the attorney will be paid the maximum fee for the highest degree felony, and will be paid up to the minimum fee for each remaining Companion Case based upon the number of hours actually worked. All case numbers are to be placed on **one** fee bill. Fees for Companion Cases must be accompanied by a Journal Entry granting the additional fees.
